This authorization shall remain in effect for the term of the collective bargaining agreement unless revoked by me within seven (7) calendar days immediately preceding the expiration of said agreement or the annual anniversary of this authorization, whichever occurs sooner. If such notice is not given in writing, this authorization shall be irrevocable for successive periods of one year thereafter, with the same privilege of revocation within seven (7) calendar days immediately preceding the end of each such one (1) year period.
